REPORT OF THE COUNCIL CHAIR CARL SCHLACK

The past Council Year (May 2022 to May 2023) has been both eventful and challenging. When the new Council Year started, we had come through the worst of the COVID-19 pandemic with our canoe upright and heading into what looked like smoother seas ahead. However, we sensed things had changed and that there would be no "going back" to having everything being just the way it used to be. COVID taught us that the life we knew and were comfortable with could change in a heartbeat, and that we needed to be able to adapt and adjust to change. The good news is that because the congregation, clergy, and staff proved to be both adaptive and resilient, the Good News of the Gospel continued to emanate from the people that are Central Union Church.

While there were many notable events during the past Council Year, allow me to highlight a few of the more significant ones:

We started our year by identifying projects and staffing needs that needed addressing, and we received updates from two existing committees whose ongoing work will impact the future of Central Union Church; the Senior Minister Search Committee and the Vision Team. One of the projects to get off the ground right away was the synchronization of our fiscal, preschool, and church calendars. Our Treasurer, David Yee, worked with the Accounting Department on the necessary adjustments to our budgeting process to accomplish the synchronization of our multiple calendars. The result was that we will go through the budgeting process twice in 2023, once for the "stub" fiscal year from January 1, 2023 through July 31, 2023, and the second for the full fiscal year from August 1, 2023 through July 31, 2024. Thereafter, all our calendars will be aligned on an August 1 to July 31 fiscal year.

Pastor Brandon Durán's decision, in late summer 2022, to relocate to the mainland by the end of the year to be closer to his family, surprised and saddened many in our congregation. He had been ably serving as our Acting Senior Minister for the last two years and was a vital part of the life of our congregation for seven years. To celebrate his ministry with us at Central Union Church, many members volunteered to plan a farewell luncheon that was attended by more than 300 people in the Parish Hall. It was a heartwarming gathering that allowed church members and staff to show their aloha and deep appreciation for Pastor Brandon through music, food, dance, song, humor, gifts, a slide show, and many fond embraces. Of course, Pastor Brandon's pending departure also set in motion a concerted effort to secure temporary pastoral assistance for Pastor Mary Herbig who was soon to be the only ordained clergy at Central Union Church. In just two short years, we had gone from three ordained clergy to one, and it was uncertain when the Senior

Minister Search Committee would be in a position to recommend a Settled Senior Minister to the Church Council.

As we entered the season of Advent leading up to Christmas, our search for a "bridge" minister continued while Pastor Mary, with the help of staff and congregation members, did a truly amazing job of preparing the congregation for the coming of the Christ Child. With all the trappings and traditions of Christmas, it was a joyous December at Central Union Church. And the additional joyful news was that arrangements had been made with the Rev. Dr. David Smazik, to come to Hawai'i with his wife Ann, to serve as our Bridge Minister from early January to early May. With the help of staff and congregation members, the Manse was readied for Pastor "Dave" and Ann, who moved in just prior to his first Sunday with Central Union Church, on January 8, 2023.

The annual Budget Meeting of the congregation on January 29, 2023, had added significance this year because, in addition to affording the congregation the opportunity to review and approve the annual budget for the "stub" fiscal year from January 1, 2023 through July 31, 2023, it also served as the forum for the Vision Team to present its recommendation to the congregation on how best to address CUC's mounting challenges of a shrinking congregation, a restrictive stewardship environment, rising deferred maintenance costs, and an increasing reliance on income streams outside of congregational control. Between the Budget Meeting on January 29, 2023, and the Special Meeting of the Congregation on March 5, 2023, that was called to vote on the Vision Team's proposed recommendation, the Vision Team held six informational meetings with the congregation to discuss the proposed recommendation. On March 5, 2023, the congregation of Central Union Church voted to approve the Vision Team's proposal to grant the Church Council the authority to enter into long-term ground leases and/or to sell portions of the Honolulu and Windward campuses so that

underutilized portions of our real estate assets could be used to further the mission of Central Union Church. It was a bold vote and a significant statement; and it was consistent with the church's commitment to develop the financial resources needed to secure its ability to continue ministering to the spiritual needs of the congregation while simultaneously doing God's work in our community.

Easter services at Central Union Church on April 9, 2023, were well attended and full of joyful noise! For the first time in years, attendees had the option to not wear a mask. When CUC re-opened for in-person worship services in October 2020, precautions were taken to mitigate the spread of COVID-19 and protect the health of our members. These precautions included temperature taking before entry to the church, social distancing in the pews and, of course, mask wearing. During the next two and a half years, despite increasing mask fatigue, congregation members and staff dutifully followed the church policy of wearing a mask when on church property notwithstanding the relaxing of other precautions. As the severity of the public health threat slowly diminished, the Reopening Liaison Team and the Church Council revisited the mask policy and decided the CUC campuses would become mask optional after the Winter cold and flu season passed. Thus, as of March 26, 2023, services and events on CUC campuses became mask optional and it has been wonderful to see so many smiling faces (especially on Easter Sunday). Many thanks to the Reopening Liaison Team (and particularly, Dr. Nathan Wong and Bruce Luxton) for guiding Central Union Church through this "once-in-a-lifetime" (we hope) event.

A few other happenings at Central Union Church during the past Council Year that are worthy of note: (i) Central Union Preschool ("CUPS") continues to thrive under the leadership of Director Veronique Braithwaite and the dedicated CUPS teachers and staff who held another successful Dazzle Fundraising Event on our Honolulu campus at the end of April 2023; (ii) the Thrift Shops on our Honolulu and Windward campuses are carrying on vibrant ministries that serve a need in our communities; (iii) our Children and Youth Ministries are becoming increasingly active; (iv) the Serving Aloha program, held every Wednesday on our Honolulu campus, continues to be an amazing expression of care and love by addressing the food insecurity of 500 to 600 people or more each week, and is one of our brightest ministry lights; and (v) our volunteers (CUC members and non-members alike) are people filled with grace who care for each other and who exhibit acts of love and generosity.

Much has been accomplished this past Council Year but much more remains to be done. We look forward to continuing the good work of Central Union Church during the next Council Year (May 2023 to May 2024).

REPORT OF THE REOPENING LIAISONS NATHAN WONG AND BRUCE LUXTON

By Easter 2022, CUC had come through the previous two years, the thick of the COVID Pandemic, fairly well. Our mitigation measures had resulted in no spreader events. Our worship services had gone from online only to the reopening of the Sanctuary to in-person worship at 9:00 AM in October 2020. There had then followed the reopening of the CUW 10:30 AM and Pohnpeian 11:30 AM services. Singing had resumed and progressed from a single soloist to our four soloists to our eight-member Ke Aloha Pau 'Ole to our full choirs and finally, joyfully, to the congregation, just in time for Easter 2022. Communion had resumed in the form of pre-

packaged units of bread and juice.

In the past year, we have resumed inperson services in the Parish Hall at 11:00 AM (April 2022) and in Atherton Memorial Chapel at 7:00 (November 2022). Through all this time, online services in English and Pohnpeian have continued and thrived, welcomed by a growing and loyal body of worshipers. Increased immunity to COVID in the community and congregation through vaccination and previous infection allowed the gradual reduction of our mitigation measures to that of required masking. As 2022 ended we were made aware of increasing requests from both choirs

and congregation to make masking optional. Because the Winter of 2022-2023 brought the additional risk of seasonal influenza and respiratory syncytial virus (RSV) to COVID, we felt that action should best wait until Spring. Therefore, on Sunday, March 26, 2023, masking became optional in services and on campus for both Honolulu and Windward in time for Palm Sunday and Easter 2023.

In retrospect Reopening Liaisons Bruce Luxton and Nathan Wong feel CUC has successfully negotiated the COVID Pandemic safely in compliance with State and City requirements due in no part cooperation small to collaboration among clergy, staff and congregation, and ultimately to God's abundant grace. We are grateful. We can now back down from direct action to a state of vigilance as CUC resumes full church life, remembering that COVID is still with us and likely will be for some time.

REPORT OF THE COMPTROLLER AND TREASURER DAVID YEE, TREASURER

The Accounting Department was short-staffed and thus extremely busy with the management of our financial affairs in 2022/2023. Like the rest of our Church, they were impacted by the significant changes in senior leadership. CUC did not hire a third pastor, lost our acting Senior Minister, and started and ended the year without an EOO or Comptroller. During the year an EOO and two Comptrollers were hired, and quit, leaving the Accounting Department without the very people that should be directly supporting and supervising them. The turnover was stressful and resulted in operational inefficiencies. The two staff accountants, Amy Inouye and Leslie Lui-Yuen, had to deal with the consequences of not having a Comptroller, the key third member of the Accounting Department for almost six months of the year. The good news is that a Comptroller is expected to be hired soon. The offer letter is being prepared.

Highlights and achievements:

- The Church Council has, for years, talked about improved financial reporting and updating our old accounting software. This year we were able to meet two of the Council's requests without the need to buy new software.:
 - 1) They now produce consolidated financials. Due to having two separate sets of books, one for the Church and one for the Preschool, the monthly financial reports to the Church Council did not include all the Preschool details except at year-end when a special consolidated report was run. Council now receives consolidated reports monthly instead of annually.
 - 2) CUC changed to the same July 31st fiscal year-end. The Church had a December year-end while the Preschool always used July. Now consolidated statements and annual budgets are easier to combine and understand.
- ERC (Employee Retention Credit), a relief program first recommended by Veronique Braithwaite, Preschool Director, was applied for and received. This was in addition to the prior year's \$1,200,000 of PPP (Paycheck Protection Plan).

600,000 Received bequests from Helen Paris, Lucille Pratt, & Newton Pratt

\$1,468,265 = \$122,355 per month, twice the current monthly Pledge and Open Plate in the budget. CUC also received God's grace in the form of once-in-a-lifetime gifts during CUC's COVID transition period.

• The Church Council recommended, and the Congregation approved, a motion to authorize the Church Council to enter long-term ground leases and/or sell portions of the Town campus and Windward campus, the latter being subject to obtaining any necessary approvals from the Samuel N. & Mary Castle Foundation.


REPORT OF THE HISTORIAN/ARCHIVES KARL HEDBERG, HISTORIAN

On May 1, 2022, I carefully accepted the position of Central Union Church Historian.



REPORT OF THE DIRECTOR OF MUSIC MINISTRIES MARGARET LLOYD

Assisted by CUC's music staff and volunteers, I strive to provide a Christian ministry of music, serving CUC

by engaging and embracing all seeking to embody Christ. Some of my responsibilities were to:

- Facilitate worship planning for Sundays at 9 AM, 11 AM, online at 10 AM and seasonal services. The 7 AM service was reintroduced on 11/6/22, with Constance Uejio as Organist/Pianist.
- Interact with the pastoral team and Council-appointed reopening liaisons Bruce Luxton and Dr. Nathan Wong on best practices and safety protocols for in-person worship services and events. The Church Council approved a mask-optional policy in the Spring of 2023.
- Assist and support Kristen Young, Virtual Music Leader, in

developing music participation in online worship services, engaging CUC music staff and volunteers.

- Work with Wade Cambern, *Contemporary Service Music Lead*, on audio/video productions for the pre-recorded music library as a resource for online worship.
- Ensure copyright compliance for all music included in worship services, procuring permissions as necessary beyond coverage provided by ONE LICENSE and CCLI licensing agreements.
- Serve as pianist and/or organist for three local weddings and 12 memorial services.
- Collaborate with The Rev. Brandon Durán, *Acting Senior Minister*, Personnel & Pastoral Relations



Keauhou Shelter, Family Promise, and Youth Outreach:

We have been preparing and serving 160 hot meals every 2nd Tuesday of the month since the Next Step Shelter and then Keauhou Shelter opened. Even though we are no longer hosting Family Promise families, we are now including dinners for them as well as 25 meals sent over to the Youth Outreach facility in Waikiki.

Serving Aloha began in response to the growing food insecurity on our island due to COVID, but also many kūpuna have benefitted. More kūpuna and others on fixed incomes show up regularly now. Every Wednesday morning, as many as 50 volunteers arrive from Central Union and Faith Action churches. The donations from the Hawai'i Foodbank are unloaded and repackaged for distribution. At the time of this report, our average has increased to 650 per week served.

White Gifts: This church year, our congregation responded generously with gifts of cash and gift cards. We were able to purchase 1,100 gifts that the agencies, non-profits, and churches rely on us to provide. They were very happy to receive them unwrapped and with enough to cover all age groups.

We provided financial donations to support the following organizations: Hawai'i FoodBank, UCC Women's Transition House, Institute for Human Services, Faith Action, John 17:21 Ministry, Hawai'i Immigrant Justice Center.

REPORT OF THE INVESTMENT COMMITTEE DAVID YEE


Purpose:

Our purpose is to preserve the endowment fund to provide current and future sources of revenue for the church. Our committee is responsible for the oversight of our professional fund manager. Bank of Hawai'i has managed our portfolio since July 1994. The total portfolio performance from July 1994 to March 31, 2023, has averaged 7.09%. The portfolio balance was \$7,061,747 as of March 31, 2023.

Highlights and achievements:



The graph above shows a slight underperformance gap that is growing as indicated by the gap between our actual and index performance. It is understood that the fund manager is being hired to be a balanced manager and a function of that tresponsibility includes asset allocation as shown in the graph on the following page. To contain risk and provide guidance to the manager, we monitor the assets allocation to a target of 60% Equity to 40% Fixed Income split. The manager has the flexibility to operate in the range of 45% to 65% for Equities and 30% to 55% for Fixed Income at any given time.

Accomplishments:

- Determined 2022 DAZZLE fundraiser allocations. This year the committee approved recommending allocating the fundraiser profits among all five "E" goals:
 - ♦ Money applied to the *economic diversity* fund to support financial aid scholarships for both the 2023-2024 school year, and a reserve fund for the 2024-2025 school year;
 - Money equally applied to endowment, events, educational opportunities, and environment funds, to make up for the last three years in which the pandemic greatly impacted preschool fundraising efforts and during which time these four areas were not funded (priority was previously and consistently given to solely awarding money to financial aid scholarships under the economic diversity fund); and
 - Remaining reserves applied to the line of credit, to proactively pay down the principal and counter rising interest rates.
- Worked with CUPS Parent Teach Organization (PTO) to review and approve allocation of excess PTO funds to be equally distributed among the nine classrooms, music class, kitchen, and after school care. Remaining amount reserved for playground equipment maintenance and improvement.
- Made recommendations to the Council regarding CUPS tuition price for 2023-2024 school year.
- Financial aid sub-committee met in March 2023 to review and approve the financial aid applications for those applicants eligible to receive scholarship awards for the 2023-2024 school year.

All Members of the SMSC were selected by Council to represent the broadest possible demographic of CUC's congregation. The Council appointed Don Clifford to serve as the SMSC's Chair.

The SMSC's highlights and achievements this past year include:

- Completed CUC's new Church Profile, in order to explain in writing to the Senior Minister candidates, CUC's history, legacy, demographics, worship practices, congregational survey results, and the status of its current ministry, committee, operational, and financial endeavors; as well as the aspirations of its faithbased initiatives.
- Completed the CUC's self-produced documentary video *Love Never Faileth*, that consisted of a very broad cross section of more than twenty interviews on camera with members of the congregation, in order to explain to the Senior Minister candidates who we are as a congregation, and what we believe.
- Completed the new Senior Minister Job Description to reflect the current needs of CUC.
- Completed more than a dozen drawings and paintings for use to illustrate the Church Profile, the *Love Never Faileth* documentary, and for the advertising of the Senior Minister position and as a way to differentiate CUC from many other competing churches also advertising for a new Senior Minister.
- Completed and launched the advertising for the Senior Minister position in multiple print and digital mediums to reach the broadest possible number of candidates. To date, we have received 86 letters of interest and 44 complete applications.
- Completed the candidate screening of the 44 complete applications and the SMSC is now in the process of interviewing shortlisted candidates, conducting follow-up interviews, and developing a group of finalists.

REPORT OF THE STEWARDSHIP COMMITTEE DONA HANAIKE AND ALEXA ZEN

The Stewardship Committee's responsibility is to solicit Estimates of Giving (pledges) from the congregation as a part of determining the annual budget. Other components of stewardship (legacy, capital campaign, grants, events/fundraising) are addressed through other groups or individuals.

Our Stewardship theme this year was "Reach" and it was based on Philippians 3:12-14. The theme of "Reach" connects to ideas of reaching out to one another, reaching out to the community to help, reaching out instead of shrinking back in, and reaching out to new goals.

A goal during the Stewardship Campaign is emphasizing generosity as a faith formation practice. Stewardship is about growing in faith through giving. We circulated the devotional, "The Big Secret of Giving: Hidden Treasures in Life and Church by William Green." Our campaign was held during the month of October and included sermons centered on this theme and mission moments by members of our



congregation. We also communicated with the congregation through letters, e-blasts, estimate of giving cards, and Zoom meetings to discuss the devotional.

As of January 26, 2023, \$378,047 in pledges were received. This includes 19 new donors and 20 donors who increased their pledge from the previous year. Mahalo to the staff and volunteers that worked on the campaign this year. And thanks to all who donated to Central Union Church through pledge, open plate giving, or other types of gifts.

REPORT OF THE CUC VISION TEAM GREG SATO



The Team's recommendation had two aims — to bolster Church finances as well as to meet the missional needs of the community. Committee members Martha Balkin, Don Clifford, Dona Hanaike, Greg Sato, Carl Schlack and David Yee, provided diligent and faithful service.

On March 5, 2023, the Congregation approved the Vision Team's recommendation. The Church Council now has the authority to enter into long-term ground lease(s) or the sale of real estate. Any lease or sale must meet the restrictions imposed by the State Historic Preservation Commission (for the Town campus) and by the Samuel and Mary Castle Foundation (for the Windward campus).




REPORT OF THE WOMEN'S LEAGUE CHARLENE LORENZO

A New Beginning:

After extensive reflection, the members of WMM decided it was time to change direction, leading us to revise our mission statement and vision. We will also give attention to connecting with the CUC community by working in partnership towards our mutual goals. VII. REPORT OF THE OUTGOING CHAIR OF THE COUNCIL, REPORT OF THE OUTGOING TREASURER, REPORT OF THE ACTING SENIOR MINISTER

Martha Balkin reminds the members that complete reports are in the CUC Annual Report booklet.

Treasurer, Craig McGinnis, reports the best way to be happy is to count the blessings and not the cash. It is best this year to count our blessings. Last year was challenging. We survived the year. We did not do great. He challenges the congregation to look past this year to the future. He reflected on the importance of giving. He discussed the amounts that we have received in pledges and the amounts we received from grants and the Federal Government. These amounts were a strong base for the church in this year. We had strong gains in our endowment portfolio the past two years so we paid off the existing mortgage. We will be debt free in 4 years based on the Preschool's annual scheduled reductions to our line of credit.

Craig ends by discussing the Capital Budget. He recognizes that we have large, deferred maintenance costs in the range of \$9 million. He is confident that we will pull together to manage this need.

Chair, Martha Balkin, discusses the prayers that we have prayed for the life of CUC. She shares that the ministry has created many opportunities for Christians to work together: The Windward campus, the Choral Scholars, the Thrift Shop, and Serving Aloha. Many Youth groups from CUC have met with other church groups. The remembrance we held on all Saints Day included many denominations. She believes this congregation can move forward into the future. She is grateful to the ministries and the staff for their faithful work. She is grateful for the prayers. She leaves the Church in the capable hands of incoming Chairperson, Carl Schlack.

Acting Senior minister Brandon Durán reports that we have had many programs and challenges this year. The congregation managed to step up to these challenges this year. We pray for the direction of the church in the future. As we move forward, we need to set a "Disposition of the Heart". We need to be willing and able to move forward with the will of God. Our actions will be part of our prayer. The Disposition of the Heart holds a willingness to be of service to our neighbors.

The Chair reports in accordance with Section 4.3.D of CUC's Bylaws, the nominated candidates are duly elected for the positions, and for the terms specified.

Outgoing Chair, Martha Balkin, turned the meeting over to incoming Chair, Carl Schlack.

Carl recognizes that one member of CUC deserves special recognition. He explained that Martha

guided CUC through a world-wide pandemic that turned CUC's world upside down. Shortly after she began her term as Chair, our Senior Minister resigned. Many difficult decisions had to be made. Martha's strong leadership skills and her inclusive nature proved to be the right formula to guide our church. Carl said the best leaders lead by example. Martha is a "roll up your sleeves, let's get to work" kind of leader who leads from the front. Carl presented Martha with the paddle of the canoe steersman for guiding our church through turbulent waters. There was a very long standing ovation for Martha.

Greg Sato Greg Sato, Chair of the Vision Team, presented a PowerPoint slide show entitled The Road to Emmaus. The Vision Team is looking into the future of the church. They have identified goals and looked at the assets CUC has to move forward. They are looking at a range of 5 years to 50 years forward. Greg recaps the amounts given by age groups and cash flows from campus tenants and businesses. The church campus businesses provided more money that the congregation. The church has a reverse pyramid. Many of our oldest givers are the highest givers. We have many years of deferred maintenance.

Greg recalled how we raised money for the church roof. He mentioned the successes of the church, including the fact that the weekly showing of the Pohnpeian service over the internet is reaching thousands of individuals weekly.

Greg asked us to move forward with God's will and to pray for the Vision Team.

XI. PRESENTATION OF THE SENIOR MINISTER SEARCH COMMITTE _____ Don Clifford Don introduced the members of the Senior Minister Search Committee ("SMSC"). He also introduced the "ambassadors" of the Search Committee.

Don Clifford updated the congregation on the work of the SMSC. He presented the key ideas about the process and recaps the work of the committee including the writing of the job description and the advertising system that is to be used. He discussed the UCC "ministry call" requirements and the conditions that need to be met under our Bylaws. They have had long discussions about why we lost a Senior Minister. They have a sense of urgency to move forward.

Don shows a five minute "clip" of the thoughts of Central Union members. The clip has been done as a part of a longer movie that will be used to deliver to potential minister candidates. It is a movie about the people of Central Union Church and their commitment to Christ.

I. ESTABLISHMENT OF QUORUM

Call to Order – 11:18 AM _____Carl Schlack

Council Chair, Carl Schlack, welcomed members and informed them we are waiting for the final member count to determine whether we have a quorum.

Secretary Reem Bassous is informed of the member count, and she informs the congregation that a quorum has been established. Carl calls the Annual Meeting of the congregation of Central Union Church ("CUC") to order at 11:18 am.

- II. NOTICE OF BUSINESS FOR THE ANNUAL BUDGET MEETING

 Carl Schlack Carl described the purpose of the meeting as two-fold: to consider and approve our annual budget, and to hear a presentation by the Vision Team. He announced that notice was properly given in accordance with the requirements of CUC's Bylaws, and that the meeting will be conducted in accordance with the Congregational Meeting Rules adopted by the Council on September 25, 2012, and the Council Resolution authorizing congregational meetings via electronic technology adopted by the Council on January 26, 2021. He noted there are a number of members with us on Zoom, including members at CUC's Windward campus.
- III. INVOCATION Pastor Mary Herbig Pastor Mary provided the invocation for our meeting, asking for God's blessing upon our gathering.
- IV. INTRODUCTIONS Carl Schlack

Carl introduces the following people:

1. Council Chair Carl Schlack 2. Vision Team Chair and Parliamentarian **Greg Sato** 3. Diaconate Chair and Timekeeper Martha Balkin 4. Secretary Reem Bassous 5. Treasurer David Yee 6. Carl explains to the members the rules for participating in the meeting and voting on motions and asks for patience since we are running a hybrid meeting (i.e., in-person and Zoom participants). A sample ballot is used to allow Zoom members to practice voting.

V. PRESENTATION OF THE BUDGET ______ David Yee Carl Schlack calls on David Yee, as Treasurer and Chair of the Budget Committee, to present the budget for January 1, 2023, to July 31, 2023.

David Yee presents the budget and explains that this 7-month budget is necessary to align the Church fiscal year with the Preschool fiscal year. Each subsequent budget will be a full 12-month budget that runs from August 1 to July 31 of each year. In presenting the budget, David informs the members that although the current budget is balanced, CUC stands at the precipice of a very challenging financial future since we no longer have government subsidies and revenues are not keeping pace with increasing expenses (including substantial deferred maintenance costs) and the next budget (for August 1, 2023, to July 31, 2024) will show a deficit that will only increase with subsequent budgets unless drastic action is taken.

David Yee identifies and thanks the following people who assisted in the preparation of the budget: Austen Cook, Nathan Wong, Paul Shinkawa, Thomas Kiyabu, EOO Rachel Fukumoto and the Accounting Department, and Pastor Mary and the Church Council.

Chair, Carl Schlack, opens the floor for budget-related questions, and David Yee responds to questions from members.

VI. MEMBER VOTE ON BUDGET FOR JANUARY 1, 2023, to JULY 31, 2023

Carl Schlack recognizes David Yee to provide the Motion to approve the budget. David makes the following Motion:

<u>Motion</u>: Be it resolved that the 2023 Budget, as presented by David Yee, and as recommended by the Council be, and hereby is, adopted.

Carl Schlack calls for debate on the Motion. After debate, Carl calls for a vote on the Motion and it is overwhelmingly approved with only five members opposing (two in-person members and three Zoom members).

VII. VISION TEAM PRESENTATION _________ Greg Sato Carl Schlack calls on Vision Team Chair, Greg Sato, to present the Vision Team's recommendations to address the very challenging financial future described by David Yee during his presentation of the Budget. Greg explains the Vision Team's conclusion that to create a long-term revenue stream to cover CUC's growing operational and maintenance costs, and to allow member contributions to fund CUC's missions, the congregation needs to authorize the Real Estate Committee to enter into long-term ground leases or sales of portions of our Honolulu and Windward campuses. Greg indicated the Council will call a Special Congregational Meeting for March 5, 2023, to have the congregation vote to authorize such action. Beforehand, throughout the month of February, the Vision Team will hold a series of meetings with the congregation to discuss this proposal.

Members were given time to ask questions which were responded to by Greg or other Vision Team members (i.e., Greg Sato, Martha Balkin, Carl Schlack, David Yee, Dona Hanaike and Don Clifford).

PRESENTATION OF THE MOTION Greg Sato
Pastor Dave calls on Greg Sato, Chair of the Vision Team, to present the Motion.

Greg summarizes the very challenging financial future faced by CUC as was presented by Treasurer, David Yee, at the Annual Budget Meeting on January 29, 2023, and as subsequently discussed with CUC members in a series of "town hall" meetings held throughout February 2023. Greg reminds everyone that the original Motion discussed at the Annual Budget Meeting has been modified to authorize the Church Council, not the Real Estate Committee, to enter into long-term ground leases or sales of portions of our Honolulu and Windward campuses, and then restates the Motion as follows:

THE CHURCH COUNCIL IS HEREBY AUTHORIZED TO ENTER INTO LONG-TERM GROUND LEASES AND/OR SELL PORTIONS OF THE HONOLULU CAMPUS AND THE WINDWARD CAMPUS, THE LATTER BEING SUBJECT TO OBTAINING ANY NECESSARY APPROVALS FROM THE SAMUEL N. & MARY CASTLE FOUNDATION.

VII. QUESTIONS OF CLARIFICATION ON THE MOTION

Pastor Dave asks if there are any questions of clarification (not debate) regarding the Motion. A couple members have questions that are answered by Pastor Dave and Carl Schlack.

VIII. **DEBATE ON THE MOTION**

Pastor Dave calls for debate on the Motion, specifies the rules of debate, and moderates the debate alternating between those in favor of the Motion and those opposed to the Motion. A lively debate ensues. As debate is winding down, a motion is made to "call the question". A vote is held on the motion to "call the question" and it is overwhelmingly passed, thus ending debate.

IX. **VOTE ON THE MOTION**

Pastor Dave announces that for the Motion to pass, it needs the affirmative vote of a majority of members present at the meeting. He then restates the Motion and calls upon all members present (in person and on Zoom) to vote on the Motion. After tabulating the votes, Pastor Dave announces that the Motion has passed with 105 members voting in favor, 59 members voting against, and 3 members abstaining. Pastor Dave then turns the meeting back over to Council Chair. Carl Schlack.
